



# Buyer's Guide:

## What textbook option is best for you?



1. **Online Book:** This is our least expensive textbook option. You can access your Online Book via our new ePub Reader (recommended) or by using Microsoft's **Silverlight™** platform (note limitations). The ePub Reader works with most browsers and on most devices. The **Silverlight™** version works on major laptops, but not on portable devices like Kindle, iPad or smart phones. And is limited to either Internet Explorer or Firefox browsers.

The basic version of our online book includes search, highlighting and note taking functionality. If you want printing capabilities, we recommend one of the options below. The online textbook is available immediately after checkout.

2. **The Digital Bundle (Printable PDFs + Basic Online Book):** Available for all textbooks and some (not all) study guides. The digital bundle provides you with two versions of the textbook: the online book (see above) and a PDF version that's packaged in chapter downloads. The pdf files enable the user to study offline when internet connection isn't available. The textbook is available immediately after checkout. Print directly from the opened PDF, or download/save the PDF by clicking on "File", then "Save As" from your toolbar.

### 3. Hybrid Bundles: 3 options for those of you interested in studying using a paper version of your textbook:

**#1 (Loose-leaf + Online Book):** Another "two-for-one" option: a one-color loose-leaf version of the book plus free access to the Online Book. Fits in 3-ring binder (not provided). Use the Online Book while the black & white loose-leaf is shipped directly to you (allow up to 7 business days).

**#2 (One-Color Paperback + Online Book):** this Hybrid Bundle includes a bound, black & white paperback textbook **plus** access to the Online Book. Use the online version while your paperback ships directly to you (allow 5 to 7 business days). Details on how to order are provided when you select this option.

**#3 (Color Paperback + Online Book):** this Hybrid Bundle includes a bound, **color** paperback textbook **plus** access to the Online Book. Use the online version while your paperback ships directly to you (allow up to 7 business days). Details on how to order are provided when you select this option. (Available for select titles.)

**Analyzing Strengths, Weaknesses, Opportunities, and Threats**

After identifying the organization's mission and strategic goals (as discussed in the previous section), the long-term future. From the firm's viewpoint, there are two overriding entities or factors that are essential to take into consideration in strategic planning. **SWOT analysis** is a tool that identifies an organization's internal strengths and weaknesses and the opportunities and threats that exist in its environment. Figure 6.4 demonstrates the components of a SWOT analysis.

**SWOT analysis:** The evaluation of the organization's internal strengths and weaknesses and the external environment.

A strength is an ability or attribute internal to the organization that has the potential to give the firm a competitive advantage. A weakness is a skill or attribute that the firm lacks or one that it has not developed. An opportunity is an environmental circumstance that is potentially beneficial to the firm. A threat is an environmental circumstance that is potentially harmful to the firm. The U.S. population provides an increasingly large market for organizations that produce goods and services.

attention to the external environment and the long-term goals of the firm. In fact, we have defined strategy in terms of organization's resources and its environment in order to achieve its goals. It should be no surprise, therefore, that the strategic planning process are similar to those discussed previously with regard to general planning.<sup>14</sup>

**Analyzing Strengths, Weaknesses, Opportunities, and Threats**

After identifying the organization's mission and strategic goals (as discussed earlier), the organization must decide where it wishes to be in the long-term future. From the firm's viewpoint, there are two overriding entities or forces that determine this—the organization and its environment. These are essential to take into consideration in strategic planning. **SWOT analysis** (Strengths, Weaknesses, Opportunities, Threats) means evaluating the organization's internal strengths and weaknesses and the opportunities and threats associated with the business's external environment. SWOT analysis emphasizes that the fit between a firm and its environment is of paramount importance, and the firm's strategy should be built around this match. Figure 6.4 demonstrates the components of a SWOT analysis.

**SWOT analysis:** The evaluation of the organization's internal strengths and weaknesses and the opportunities and threats associated with the business's external environment.

A strength is an ability or attribute internal to the organization that has the potential of giving it a distinctive competence. Potential strengths include the firm's financial capability, its management skills, cost advantages, proprietary knowledge, and/or its brand name, to name a few. Conversely, a weakness is a skill or attribute that the firm lacks or one that it has not developed and at which it performs poorly, such as failing to provide adequate customer service.

An opportunity is an environmental circumstance that is potentially beneficial for the firm. For example, the increasing proportion of older adults in the U.S. population provides an increasingly large market for organizations that offer health care and recreational services.

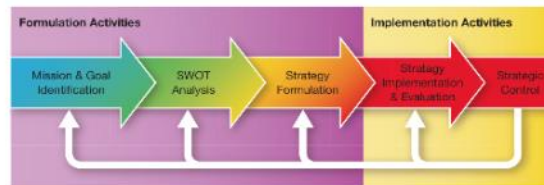


FIGURE 6.3 The Strategic Management Process
